AN ORDINANCE RELATING TO THE ADOPTION OF CERTAIN SECTIONS OF THE LAND DEVELOPMENT CODE FOR ALL OF JEFFERSON COUNTY KENTUCKY

WHEREAS, the City has received and reviewed the recommendations of the Louisville Metro Planning Commission relative to the adoption of the Land Development Code (March 2006 edition); and

WHEREAS, the City wishes to adopt certain provisions of said Code without adopting the Code in its entirety; now, therefore,

BE IT ORDAINED BY THE CITY OF INDIAN HILLS,
