**AN ORDINANCE AMENDING INDIAN HILLS ORD. NO. 6, SERIES 2003
SETTING DAY OF MONTHLY CITY COUNCIL MEETINGS**

WHEREAS, it is the desire of the Indian Hills City Council, and in the best interest of the City of Indian Hills, Kentucky, to utilize the authority granted in KRS 83A.060(3) to amend city ordinances and further to ensure compliance with ordinances in force within the City of Indian Hills, and

WHEREAS, City of Indian Hills Ordinance No. 6, Series 2003 should be amended to reflect changes made to the day of City Council meetings of Indian Hills, and the specific section amended is to be herewith set out in full.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF INDIAN HILLS:

SECTION 1. City of Indian Hills Ordinance No. 6, Series 2003 is hereby amended to reflect changes made to the day of City Council meetings of Indian Hills. The specific section amended is herewith set out in full.

1. The official meeting place of the City Council is Louisville Boat Club, 4200 River Road, Indian Hills, Jefferson County, Kentucky.
2. The City Council shall hold its regular meetings the third Wednesday [~~Thursday~~] of each month at 6:00 p.m.
3. If the regular meeting date falls on a legal holiday as defined by Kentucky Revised Statutes, the regular meeting shall be on the next following date which is not a legal holiday.
4. Special meetings may be called as provided by law.
5. All meetings of a quorum of the City Council shall be open to the public and all public records of the City Council shall be open for inspection by any person in accordance with KRS 61.805 to KRS 61.884.

SECTION 2. Severability. The provisions of this ordinance shall be considered severable. If any provisions of this ordinance are found to be invalid, that finding shall not necessarily invalidate the entire ordinance.

SECTION 3. Effective Date. This ordinance shall become effective after passage, approval and publication as required by law.
