PREPAYMENT OF VIOLATIONS

Many violations are payable prior to the court date. By prepaying, you are also pleading guilty to the violation(s). If you prepay you do not need to appear in court. To do so, follow these steps:

- 1. Look on the reverse side of this sheet and find the violation code(s) and fine(s) for which you were cited.
- 2. Place the fine amount(s) listed for the violation(s) on the Payment Due Worksheet located on the back.
- 3. Add the fine amount(s) to the Court Cost of \$134.00 as indicated and pay that total. Please include copy of citation.
- 4. <u>CRIME STOPPER FEE INFORMATION</u> IF YOU ARE CITED FOR OFFENSES DESIGNATED BY CODES 02304, 02305, 00427, ENTER \$1.00 ON THIS LINE. FOR ALL OTHER OFFENSES LISTED ON THE BACK OF THIS SHEET, ENTER "0".

Payments may be made through one the following means:

- Pay online Your citation and/or traffic school may be eligible to pay online. To check, go to http://kycourts.gov and click on the Pay Fine/Fee icon.
 - Online payments MUST be made at least three (3) business days prior to the court date listed on your citation.
- Pay by Phone If you wish to pay-by-phone, call 1-866-396-1751.
- Pay in Person If you wish to pay in person, you may do so at the Hall of Justice, 600 West Jefferson St. Louisville KY 40202. You will pay on the first floor at the Circuit Court Clerk's District Criminal Division. You may pay between the hours of 7:30 am 11:30 pm, Monday through Saturday.
- Pay by Mail All payments MUST be mailed at least seven (7) business days prior to your court date to:

Payments may be made by:

- Certified Check Make all certified checks payable to the Jefferson Circuit Court Clerk.
- · Money order Make all money orders payable to the Jefferson Circuit Court Clerk.
- Credit or debit card (Discover, American Express, Master Card or Visa) A convenience fee will apply to credit/debit card payments.
- · Cash payments are accepted in person only.

PLEA OF NOT GUILTY

If you wish to contest the citation or plead not guilty, please appear in court on the date and time shown on your citation. For general information about court dates and times, go to https://kcoj.kycourts.net/kyecourts/login/guestlogin or visit www.jeffersondistrictcourt.com.

FOR KENTUCKY RESIDENTS ONLY: APPLYING FOR TRAFFIC SCHOOL PRIOR TO YOUR COURT DATE

If the violation for which you have been cited has an asterisk (*) beside it, you are eligible to apply for State Traffic School as long as you have a valid Kentucky driver's license and have not attended State Traffic School within the last twelve (12) months. To apply, you may go online to http://kycourts.gov or you may apply in person at: 600 W. Jefferson Street, Louisville, KY 40202. You will be billed an additional fee by the school at a later date. If you choose this option, you do not need to appear in court.

EQUIPMENT, DRIVER'S LICENSE, REGISTRATION AND NO LIABILITY INSURANCE VIOLATIONS

- 1. Equipment Violations If you are cited for one of the equipment violations listed on the reverse side, you may bring in or mail in proof of repair (repair slip must be the original and must show what was repaired or what was purchased).
- 2. License Offense(s) If you are cited for one of these offense codes, 00380, 00435 or 00436, you may bring in or mail in a copy of a valid operator's license (U.S.).
- 3. Improper Registration Plates, No/Expired Registration Receipt, Improper Registration or No/Expired Registration Plates If you are cited for one of these offense codes, 00405, 00407, 00408 or 00424, you may bring in or mail in a copy of your new registration.
- 4. No Liability Insurance If you are cited for this offense, the County Attorney requires the vehicle registration and a signed letter from your insurance agent or company stating that the insurance was valid at the date and time of your violation. This letter must include the effective date of coverage and your vehicle's VIN. Bring in or mail in a copy of your vehicle registration and the original letter signed by your insurance agent or company (faxed copies will not be accepted).

Offenses not listed on the back of this sheet are NOT prepayable and REQUIRE attendance in court.
