Online Instruction - Asynchronous: Asynchronous learning allows you to learn on your own schedule, within a certain timeframe. You can access and complete lectures, readings, homework and other learning materials at any time during a given period. There may be sequenced assignments that must be completed at specified times.

Virtual Instruction - Synchronous: Synchronous learning means that although you will be learning from a distance, you will virtually attend a class session each day, at the same time as your instructor and classmates. The class is a firm, daily time commitment that cannot be rescheduled.

Blended Instruction: Includes both classroom instruction and Online - Asynchronous.

1115-20JR**ACADEMY OF POLICE SUPERVISION****120 Hours**

APS is the first course in the leadership development for sergeants or first line supervisors. Students are expected to complete all reading and writing assignments and to actively participate in practical based exercises designed to develop or enhance their supervisory abilities. Students can expect assignments that will require them to perform activities during hours outside the normal classroom times. The learning outcomes for this course will be for students to apply situational leadership and demonstrate an understanding of constitutional and administrative law, emotional and social intelligence, change, ethical decision making, problem solving, emotional survival, and public speaking into their role as a supervisor. Students must be capable of moderate physical activity; therefore, this course is not suitable for students on light or restricted duty. An agency Class A uniform will be required dress on certain dates (business suit and tie if not assigned to uniform duty). Due to demand, no Corporals or persons on a promotion list will be admitted.

Video review of incidents/discussions related to CIT will be part of this course.

This course covers a variety of narcotics enforcement issues from case initiation to court presentation. Topics include state and federal narcotics laws, investigating conspiracy cases, analyzing intelligence, surveillance, history and pattern of drug trafficking, drug identification, field-testing, and the collection, preservation and submission of drug evidence.

In addition to classroom lecture, interactive practical exercises will be used to assist in the instruction of undercover drug operations, informant debriefing, and raid planning and execution. Instruction will be provided by the U.S. Drug Enforcement Administration.

0782-22J**BASIC OFFICER SKILLS****40 Hours**

This re-certification training is exclusively for peace officers who are employed or appointed by a law enforcement agency and must be certified to meet KLEC training requirements for active certification purposes mandated by KRS. This course is intended as refresher training and certification of skills for officers who have been academy trained in Kentucky and are returning to law enforcement after a break in service. The training will cover the high consequence and liability areas of emergency vehicle operations, firearms training and qualification, traffic-stop tactics, and defensive tactics. Officers will have to successfully pass a written exam, firearms qualification, handcuffing techniques, and emergency vehicle operations qualification to successfully complete this course for recertification.

NOTE: This course does require the intermediate/moderate physical capabilities associated with firearms training (e.g., positional shooting from kneeling to standing and standing to kneeling), emergency vehicle operations driving, and defensive tactics related to handcuffing and other techniques.
