CITY OF INDIAN HILLS will receive sealed bids for street resurfacing, said bids to be received until 12 p.m. Noon on April 16, 2025. Address all bids to City of Indian Hills, c/o Chip Hancock, Mayor, 3905 Brownsboro Road, Indian Hills, KY 40207-1823, which will be the place of the bid opening. Copies of detailed specifications can be obtained at aforementioned office or contact Mr. Jim Graven, Public Works Director, at 552-4250.

The general nature of the work to be performed is street resurfacing of certain streets as marked in the City of Indian Hills.

Detailed specifications shall control notwithstanding this statement as to the general nature of the work. Bidder shall be responsible to determine all quantities. Work must be started within 21 days of bid award. The City reserves the right to reject any and all bids.

## TECHNICAL CONDITIONS CITY OF INDIAN HILLS

#### **INFORMATION FOR BIDDERS**

- 1. You are invited to submit bids for resurfacing streets in the City of Indian Hills. Sealed bids will be received at the office of Mayor Chip Hancock, City of Indian Hills, 3905 Brownsboro Road, Indian Hills, KY 40207-1823, until 12:00 p.m. Noon, on April 16, 2025, at which time the bids will be publicly opened and read.
- 2. Bidders must visit site of work, examine plans and each bidder must make his/her/its own appraisal of the quantity of materials and cost of labor required to complete the work contemplated. A representative of the City will be made available upon request to provide any additional required information or for a meeting on-site.
- 3. Contractor agrees to indemnify and save harmless the City against any direct or indirect damages that may be suffered or claimed or from injuries to persons or property during construction of said work until it is accepted, and against claims or royalties on patents and to indemnify and save the City harmless from all losses, costs and expenses which it may sustain by reason of any negligence of the contractor.

#### **GENERAL CONDITIONS**

- 1. <u>PAYMENT TO CONTRACTOR:</u> Lump sum payment shall be made to the contractor within thirty (30) days after the completion and final acceptance of work.
- 2. <u>INSURANCE:</u> The contractor shall furnish the owner certificates of insurance showing compliance with the State of Kentucky Worker's Compensation Acts and public liability insurance of no less than \$300,000/\$1,000,000.
- 3. <u>FAILURE TO COMPLETE WORK IN TIME SPECIFIED:</u> The contractor shall commence work within twenty-one (21) days after award of contract. Should the contractor fail to complete the work within sixty (60) days after award of contract, the City shall withhold \$100.00 per day for each day of suitable working weather, except for Sundays and legal holidays, that the contractor requires to complete the work. Such money withheld is not a penalty but shall be compensation for liquidated damages, and additional costs suffered by the City due to the failure of the contractor to complete the work within the time specified.
- 4. <u>GUARANTEE:</u> The contractor shall guarantee all material and workmanship against defects for a period of one year from the date of final acceptance. Any failure of materials or workmanship during this period shall be replaced at no additional cost to the City.

#### **SCOPE OF WORK**

- Mill various roadways approx. 1.5" & haul off asphalt spoils.
- Remove debris & vegetation from roadway.
- Broom clean & tack pavement to ensure new pavement adheres properly.
- Supply & install 1.5" KYTC approved asphalt pavement.
- Stripe all affected areas using paint; use thermoplastic @ Rudy Ln & US 42 intersection.

guaranteed exact.

- All sewers and utility caps must be raised and must have traffic control at all locations at your expense.
- All stop bars to be replaced, painted white and have reflective beads and is included in the total bid price.
- No night work. No weekend work. Paving shall commence immediately after removing old blacktop.
- 5. All asphalt materials furnished shall be Class I, Type A., hot mix asphalt, meeting Kentucky Transportation Cabinet, Department of Highways, specifications for hot mix asphalt. Patrol grade edges of present asphalt street to remove all grass and dirt accumulation. Street shall be power broomed before resurfacing is begun and edges trimmed, provided however, contractor shall not blow or sweep debris from roads onto private driveways.
- 6. All equipment and procedure shall comply with the Kentucky Standard Specifications for Road and Bridge Construction, Latest Edition. Pavements including all process control and acceptance testing for an Option B job.
- 7. Mill keyways at all locations where new asphalt meets with surfaces of public streets not being resurfaced.
- 8. A tack coat of bituminous material shall be applied at a rate of 0.1 gallon per square yard to the clean existing pavement surface. The tack coat shall, in all respects, meet the Kentucky Department of Highway Specifications.
- 9. After thoroughly cleaning and priming, the surface course of one and one-half (1 ½) inches of compacted thickness of asphalt shall be installed in accordance with the aforementioned specification on street to be resurfaced. City shall be provided with state approved asphalt mix design prior to start of work.
- 10. A straight line projection of the roadway edge shall be maintained crossing all driveways. These areas to be feathered to approximately 3/4" thickness.
- 11. The crown of the existing road shall be maintained, and any existing low areas shall be properly filled in order to insure a smooth uniform surface.

- 12. Rolling of all asphalt surfaces shall be in complete accordance with the Kentucky Transportation Cabinet, Department of Highways Specifications for Road and Bridges Construction, Latest Revised Edition.
- 13. Necessary repairs to certain edges must be made in order to maintain a true edge line of the original roadway. Any manhole covers in resurfaced streets must be raised to new grade in accordance with requirements of the Louisville and Jefferson County Metropolitan Sewer District, and in cooperation with MSD, including any requirements MSD may have for cost reimbursement. Raising of MSD manhole covers shall be separately bid and billed. All other utilities and water meters, if any, shall be raised to new elevation.
  - 14. Replace existing stop bars, painted white and have reflective beads.
- 15. Specifications contained herein and details hereof shall be automatically incorporated by reference into all bids.
